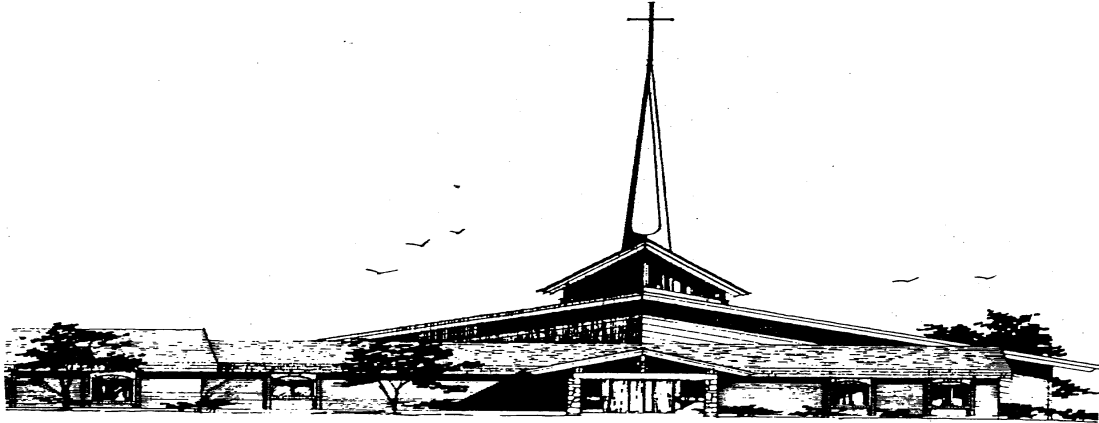

MINUTES OF THE ANNUAL MEETING OF UNION PRESBYTERIAN CHURCH

Sunday, January 26, 2014

The Annual Meeting of Union Presbyterian Church was convened in the sanctuary at 11:05 am on January 26, 2014. The 2013 Annual Report and a meeting agenda were distributed in advance. The moderator, Rev. Jesse Larson, opened the meeting with prayer. A quorum was declared, with 58 members present.

Agenda and Congregational Meeting Minutes Approved.

A motion to approve the published meeting agenda was made, seconded and approved. A motion to approve the minutes of the February 3, 2013 Annual Meeting and the Congregation Meeting minutes for meetings held on August 4, 2013 and November 24, 2013 was made, seconded and approved. A motion to authorize Session to give interim approval to the minutes of this Annual Meeting pending their official approval at next year's annual meeting was made, seconded and approved.

Pastor's Report & Clerk's Report

Pastor Larson reflected on his first months at Union. There have been joys (a hockey game with the youth group; Christmas caroling and hosting an open house; joining the African Drums ensemble; a trip to Haiti with Dr. Anderson) as well as concerns, including health issues and losses among our members. Most of all he is coming to know most or all of us and looking forward to participating in charting with us the future course of Union. The clerk's report was received without further discussion. A motion to approve both of these reports was made, seconded and passed.

Deacons Report and Prayer Shawl Reports.

The Deacon's report and Prayer Shawl Ministry Report were presented. A motion to approve these Reports as published was made, seconded and approved.

Reports of Session Committees and Special Committees.

The reports of Session Committees and Special Committees were presented. After discussion, a motion to approve these Reports as published was made, seconded and approved.

Report of Stewardship & Finance Committee, Treasurer's Report and Budget.

Paul Nelson and Bill Ross made presentations of the Financial Report and 2014 Budget. Union incurred extraordinary expenses in 2013. These related primarily to the unanticipated and premature replacement of the boiler system (in lieu of an expensive repair) and substantial renovation of the basement to remediate damages from water incursion. In addition we faced the costs associated with identifying and calling a new pastor. Thanks to extraordinary contributions of time, talent and dollars, we enter 2014 in relatively good financial shape. We still have a financial reserve of \$19,000 in money market funds available to address the budgeted deficit in the event that revenues do not rise to meet it. After discussion, a motion to approve the 2013 year-end financial statement and the 2014 budget was made, seconded and approved.

Nominating Committee.

The floor was opened for nominations of members at large for the 2014 nominating committee. Three nominees were received: Pat Rosberg, Dennis Cappel and Al Hudson. A motion to approve these three nominees was made, seconded and approved. Session and Deacon Representative to the committee will be named by each of those bodies in the near future.

Adjournment.

There being no new business and no further business proposed from the floor, the meeting was adjourned at 11:33 a.m. The meeting was closed with prayer.

In 2014, we continued our Parish program, organizing the congregation into parishes and assigning a deacon to each parish group, to enhance contact with all members. We send cards for anniversaries, birthdays, and other special occasions.

We maintain a TLC list of members and friends, many of whom are homebound. Poinsettias were delivered during Advent to those on the list.

We are linked to the prayer chain for prayer requests, which usually come through the church office. Anyone may sign up to receive the prayer chain requests. Prayers may be requested for anyone, with the permission of the person involved, by contacting Pastor Jesse, the church office, or a deacon.

We continue our tape ministry. We regularly record worship services and deliver copies of the cassette tapes, along with worship bulletins, to homebound friends who request them. We hope to transition to CD rather than cassette in the future.

We have a standing offer with Monroe Manor to transport residents for Sunday worship, but there has not been interest in the past year. We are also available to arrange transportation for others upon request.

MISSION REPORT - 2014

Union Presbyterian Church took the traditional offerings requested by the National Church: One Great Hour of Sharing - which primarily goes to hunger and disaster relief and is taken at Easter time; the Pentecost Offering - which goes to young people; the Peacemaking Offering taken in October and is used to seek peaceful solutions in many violent situations worldwide and the Christmas Joy Offering taken at Christmas, is traditionally used to ease the financial stress and crisis situations some retired ministers and missionaries face.

Hunger was our main focus for the year. We helped with food distribution at the Food Pantry the month of April and one week in December. We also helped distribute food the month of November at the St. Vincent De Paul Mobile Food Pantry. We grew, harvested and donated 187 pounds of fresh, healthy produce to the Food Pantry from our garden. November was "*Hunger Month*" in which we were given information about world hunger and references to many Biblical passages calling us, followers of Christ to answer His Call to feed the hungry.

We also donated three boxes of books to the "Send a Book to Prison" project of the Wisconsin Council of Churches. Members and Friends also participated area local missions, which included walking for Alzheimer's research, Green County Food Pantry, Big Brothers Big Sisters of Green County, Literacy Council of Green County, Christmas Stocking Fund, Second Harvest and Family Promise.

The amount of time, money, energy and creativity given by individual members is too much to be accurately reflected. The demonstrations of God's love for us...which is what mission is about ... are beautiful and inspiring.

We have had much work done on our properties since 2012. This report will summarize the projects, the costs and how we managed to pay for it.

Projects included:

Boiler and heat pump:	\$14,880.55
Roof projects:	\$55,524.46
Basement project:	\$47,568.04
Landscaping projects:	<u>\$26,547.00</u>

How did we pay for these repairs and improvements?

Property fund donations:	\$29,286.69
Roof fund donations:	\$40,502.46
Gifts and memorials:	\$22,565.49
Pasty dinner:	\$ 2,074.78
Insurance proceeds:	\$50,000.00
General fund:	<u>\$10,829.63</u>
Total:	\$155,259.05

We have been good stewards of our 30 year old building. It is amazing to note that only 7% of these projects came from the general fund.

Besides these major projects the committee budgets other expenses such as utility costs, lawn care and snow plowing, trash removal, stripping, and waxing floors.

Our building is in great shape (other than a few heating annoyances) but we still have things that need to be done.

Future projects:

- Parking lot - initial plans are to repair/replace in sections starting with closest to front door
- East stoop repair - probably hydraulics to adjust pitch
- Sidewalk repair - east section
- Consideration for an emergency exit for the west end of basement
